> Division of Parole and Probation Administrator Lisa Nixon addressed the Commission:

DPP tracks and monitors restitution cases through Case Assignment by Agent (CABA) which is available to all agents, monitors and supervisors. The report shows the total money owed, the last payment made and the balance owed.

Per DPP policy agents shall determine compliance with payment obligations by reviewing information on the database. Any non-compliance is reported to the court and/or the Parole Commission.

DPP also collects DDMP program fees, courts costs, supervision and testing fees.

Courts determine how payment plans are established. Payment plans are determined by the total amount owed divided by the number of months on supervision minus 90 days. DPP has no control over the payment plan nor can they institute a sliding scale. Unpaid balances at case closure are referred to the Central Collection Unit (CCU).
