VINE is a free service that allows you to anonymously check an offender's custody, court case, and protective order status by phone, website, or mobile app (where available). You can also register to receive automated notifications about changes in custody, court case and protective order status by phone, email, text, or in-app. TTY service for people with hearing loss is also available.

How to Use VINE:

- If you feel you are in danger, call 911 immediately.
- VINE is confidential. The offender/defendant/ respondent will not know you are registered with this service.
- VINE provides information on offender custody, court case, and protective order status in Maryland.
- VINE notifies automatically when the offender custody, court case or protective order status changes. You may get a notification from VINE in the middle of the night.
- Write down your PIN and keep it in a safe place. For safety reasons, do not share this information with others.
- If you do not answer a notification call, a message will be left and additional attempts will continue to be made for a minimum of 24 hours, or until you enter your PIN.
- Do not register a phone number that rings to a switchboard.
- You can register multiple phone numbers and email addresses for notifications.
- If you forget your PIN, call the toll-free number and press zero. You will be transferred to an operator who can help you reset your PIN, or cancel the notification.
- Operators are available 24/7 to assist you.

Phone Notifications

If registering a phone number, you will be asked to create a four-digit personal identification number (PIN). When Maryland VINE calls, listen to the message. The PIN will be used to confirm that the call was received. Make sure your PIN is easy to remember.

Note: When receiving a protective order notification, you will need to enter your PIN, followed by the # key, in order to hear the notification.



Notification Events

Once you are registered, Maryland VINE will notify you of custody, court case, or protective order status changes.

Custody Status

If the offender is in custody, you can register to be notified about the following events:

- Release Escape
 - Transfer Probation/Parole Status

Court Case Status

If court case information is available, you can register to be notified about the following:

- Court Case Status
- Upcoming Hearing Date, Time and Location

Protective Order Status

If the protective order has been filed, you can register to be notified about the following:

- Protective Order Status
- Hearing Date, Time and Location
- Expiration
